OUR REF: Sequence demolition works to Wistaston Memorial Hall

Further to your recent enquiry we are pleased to present our proposals for the above site. I have broken each element into separate options for ease.

Option (A) – Asbestos cement roof removal works only. Note: isolation of live services by others.

- Removal of suspended ceilings from within the current memorial hall in readiness for the Asbestos cement roof covering removal.
- Remove of all none notifiable Asbestos within asbestos survey produced by Griffin Environmental **03224** inclusive of providing all consignment notes.
- Disposal of all arisings to a licensed waste transfer station including providing of all waste disposal notes upon completion.

Total cost for the above works = £9,540 + vat if applicable

Option (B) - Phased demolition to Wistaston Memorial Hall

- Act as principal contractor for the demolition providing welfare and supervision for the duration of the demolition phase of works.
- Remove of all none notifiable Asbestos within asbestos survey produced by Griffin Environmental **03224** inclusive of providing all consignment notes.
- Soft strip existing Hall building removing all fixed items in readiness for mechanical demolition works.
- Demolish all structures down to slab Remove all waste from site to a licenced facility.
- Remove all slabs, footings and station bases and remove from site or crush to a 6F2 recycled aggregate. Material to be stockpiled on site in readiness for future redevelopment works.

Total cost of above works = £16,438 + Vat if applicable.

Live service isolations to be undertaken by others.

Option (C) – Phased demolition to Wistaston Tennis club inclusive of tennis courts and surrounding fencing.

- Act as principal contractor for the demolition providing welfare and supervision for the duration of the demolition phase of works. 1 week
- Remove of all none notifiable Asbestos within asbestos survey produced by Griffin Environmental **03224** inclusive of providing all consignment notes.
- Soft strip existing Hall building removing all fixed items in readiness for mechanical demolition works
- Demolish timber structures down to slab/pad foundations. Remove all waste from site to a licenced facility.
- Removal of tennis court surfaces and disposal of arisings at a waste transfer station.
- Remove all slabs/pads supporting timber structure.

Total cost of above works = £4,437 + Vat if applicable.

Live service isolations to be undertaken by others.

Option (D) Phased demolition to Wistaston Bowling club.

- Removal of surrounding hedges currently bounding the bowling green.
- Dismantle independent wooden pavilion/club house including timber sheds.
- Removal of sub hard standings and disposal from site.

Total cost of the above = £6,780 + Vat

From our discussions it was noted that the preferential sequence would be to undertake option B & C from above. This would entail ourselves demolishing the concrete garage to the left-hand side of the Hall and creating a pedestrian access to allow the tennis club to remain operational during the demolition works of the hall.

Many thanks for your enquiry requesting Brookes Demolition to provide a quote for the associated site tasks at the above-mentioned site. Further to our recent discussions/site visits regarding the works. I have pleasure in enclosing our costs for the following items.
